Fees are subject to change at the discretion of the Town Manager or Town Council. All fees paid are non-refundable.

In order for your reservation to be officially confirmed, we require that the form, plus the appropriate fee charged, be returned to the Town Manager's Office prior to the date being requested. Reservations will be on a "first come, first serve" basis. **NO RESERVATIONS WILL BE MADE OVER THE PHONE.**

Please read the **Rules and Regulations** (listed on back of the application) regarding the use of individual town facilities. Please read it carefully, sign the bottom and return with completed *Application & Reservation Contract*. **FAILURE TO READ THESE RULES WILL NOT EXCUSE YOU FROM ANY RESPONSIBILITY IN THE CASE OF LOSS OR DAMAGE TO TOWN PROPERTY!!!**

**\*If the event is held on the weekend, the key MUST be picked up by 5:00 pm on Friday or the last work day of the week, prior to the event. Failure to pick up key may result in an additional fee. \_\_\_\_\_ (Initial)**

**\*Set-up the day before "the confirmed reservation date" is NOT allowed. \_\_\_\_\_ (Initial)**

**\*All food, decorations and equipments MUST be removed from the facility once the scheduled event is over. NO items can be left at the facility until the next day. Any items left will be thrown away. The Town will not be responsible for items damaged or disposed of after an event. \_\_\_\_\_ (Initial)**

## **RULES AND REGULATIONS GOVERNING THE USE OF TOWN PROPERTY**

1. By signing the reservation contract and these rules and regulations, you hereby agree to be responsible for any damages caused by you or your group. This is including, but not limited to, damages to the Train Station building and its contents (furniture, appliances, rugs, floors, etc). **YOU WILL BE RESPONSIBLE FOR THE REPAIR OR REPLACEMENT COST (whichever is necessary) OF THE ITEM(S) DAMAGED OR STOLEN.**
2. If any alcoholic beverages are being served, you are responsible for obtaining an ABC license (Virginia ABC-Lynchburg Office at (434) 582-5136). **NO KEG BEER IS ALLOWED IN THE TRAIN STATION.**
3. NO "open to the public" or by ticket sales admission.
4. DO NOT TURN OFF ANY LIGHTS OR APPLIANCES.
5. DO NOT TOUCH THE ELECTRIC PANEL BOX OR ANY SWITCHES IN IT.
6. DO NOT MOVE OR REARRANGE ANY FURNITURE, RUGS OR EQUIPMENT!!! (unless this is approved prior to use)
7. Do not leave any food, drinks, etc. in the refrigerator. If you leave anything in the refrigerator it will be thrown away.
8. **THERE WILL BE ABSOLUTELY NO SMOKING IN THE TRAIN STATION.**
9. Please make sure you clean up after yourselves. Place all trash in the green roll out trash cans outside the rear of the building. Make sure the kitchen is clean and free of food, trash, etc. The building must be cleaned IMMEDIATELY after the event.
10. You must remove any equipment, decorations, etc. belonging to you or your group as soon as you finish using the facility, unless other arrangements are made. There may be other groups using the Station after you.
11. If the event is catered, the name, address and telephone number of the caterer may be required. The Town reserves the right to refuse use of the facility if the caterer has been a problem in the past with clean up of the facility.
12. **The Town of Farmville will not be responsible for supplying any type of equipment, tables or chairs needed. All property is rented "as is".**
13. If all of the above conditions are met and your reservation is approved, you may pick up the key for the selected town property at the Town Administrative Offices on the day of the event. **If the event is held on the weekend, the key must be picked up on the Friday prior to the event.** The Town Office is not open on weekends. All keys must be returned on the first business day following the event.
14. The Train Station shall not be used for any events for which an admission charge or entry fee is required for admittance or attendance.

### **FAILURE TO READ THESE RULES WILL NOT EXCUSE YOU FROM ANY RESPONSIBILITY IN THE CASE OF LOSS OR DAMAGE TO TOWN PROPERTY!!!**

The user agrees to hold harmless the Town of Farmville or any employee or agent acting on behalf of the Town of Farmville and to indemnify them from any claim, demand or action by or on behalf of any person or entity arising out of any activity not sponsored by the Town of Farmville at or on the Town's property that occurs as a result of the rental of the Town Property including, but not limited to, its establishment, construction, use, maintenance, configuration or existence.
